Report Narrative  
**On 091708 at about 0430 hours I, Officer Foulks, along with Officers G. Smith, C. Jones, B. McVay, E. Fehlman, J. Bowers, C. Stephens, and Sgt Tanner, responded to a business burglary call at the Knoxville Museum of Art at 1050 Worlds Fair Park Dr. The call was placed by the suspect, Richard Smith, who stated he was stuck in an air duct that leads from the room. With assistance from the Knoxville Fire Department officers made access to the roof. A rope was found, tied to a cable that ran along the roof, which went into an air duct on the north side of the building. When officers looked into the air duct the suspect was discovered about forty five feet below the roof. The suspect made the statement "Mission Failed". With assistance from KFD the suspect was pulled from the air duct without injury.**

**After being read his Miranda Rights, the suspect stated that he was a special agent with the United States Illuminati, badge number 0931. The suspect stated he was sent on a mission by Director Womack to "Defuse and Confiscate a Soviet made MERV 6 SS-22AN war head with a 14.5 Kilogram of enriched Uranium and a Plutonium Trigger capable of delivering a 40 Kiloton yield." The suspect stated that the device was concealed in a "blue plastic cow sculpture" in the basement of the museum. The suspect also stated that while he was in the air duct he received a call from his "agency" that they made a mistake and the device is actually in a museum in Memphis. When asked how the suspect got onto the roof, he stated that he repelled from a CH2 Huey.**

**After checking the room area officers discovered that the Museum has a step design on the north and south side of the building. On the south side of the building an ash tray was pushed next to the building and it is believed to be where the suspect gained access to the roof. The key holder from the Museum was notified by Sgt Tanner and given a case information card. The suspect was charged with aggravated burglary. Officer Fehlman took photos of the scene with his digital camera. The suspect stated that he did not receive any injuries from the incident and did not need medical attention. The suspect was transported to Knox County Intake by Officer Jones.**

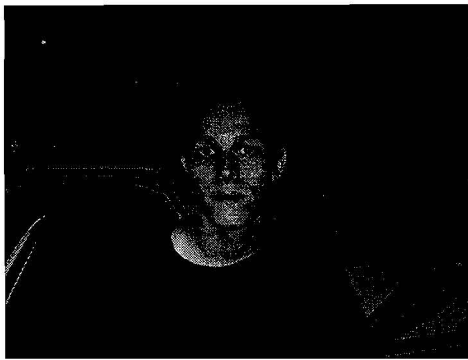
