KRONENBERGER DECL. IN SUPPORT OF EX PARTE APP. FOR TRO

I, Karl S. Kronenberger, declare as follows:

- 1. I am an attorney admitted to practice law in the State of California, and I am admitted to appear before this Court in the above-captioned matter on a pro hac vice basis. I am a partner at the law firm of Kronenberger Rosenfeld, LLP (the "Firm"), which is counsel of record for Plaintiffs John Doe 1, John Doe 2, and John Doe 3. Unless otherwise stated, I have personal knowledge of the facts set forth in this declaration.
- 2. As part of my firm's engagement with Plaintiffs John Doe 1, John Doe 2, and John Doe 3, each Plaintiff disclosed his identity to my Firm with the understanding that the Firm would seek to preserve their identities under the relevant Ninth Circuit authority that allows for parties to appear pseudonymously in litigation in certain circumstances. *See Does I thru XXIII v. Advanced Textile Corp.*, 214 F.3d 1058, 1067 (9th Cir. 2000).
- 3. Before filing this lawsuit, I reviewed the Ashley Madison website located at <downlow.ashleymadison.com>, the services the website purports to offer, and the process for enrolling in/acquiring the website's services. Based on my review of the Ashley Madison website, I determined that Ashley Madison is a dating website and social networking service marketed toward people who are married or in a committed relationship. Ashley Madison requires its users to submit personal information to create profiles.
- 4. Each Plaintiff informed me that he previously created a profile with the Ashley Madison website, at which time he provided the website with personal information, including his name, postal address, and email address.
- 5. The Ashley Madison website makes several statements that it will safeguard its users' personal information.
- 6. Attached hereto as **Exhibit A** is a true and correct printout from a webpage within the Ashley Madison website, which displays the frequently asked question, "Will 'Ashley Madison Down Low' show on my credit card statement?" My office accessed and printed out this webpage on September 9, 2015 from the following URL:

- 14. While the different Roe Websites provide various (and often inconsistent) explanations of where their data is located and how it is searched, each Roe Website enables users to search for registrants of the Ashley Madison website.
- 15. Attached hereto as **Exhibits J-M** respectively are true and correct printouts of the WHOIS data for the Roe Websites, which my office obtained on September 9, 2015 using the Domain Tools service. As indicated by these exhibits, some of the WHOIS information is "privacy protected," meaning that all information concerning the true owner and operator of the website has been concealed through the use of an unrelated privacy protection service. While other information in the WHOIS data appears to contain real names and addresses, it is inconclusive as to whether these names and addresses relate to the true operators of the Roe Websites—i.e., the Roe Defendants—or comprise fictitious identifications or merely refer to web development or registration services. Accordingly, confirmation from the hosting companies is necessary to identify and name the Roe Defendants.
- 16. Exhibit M shows that the website associated with <greyhatpro.com> is hosted by Cloudflare Inc. ("Cloudflare"). However, a representative of Cloudflare informed me that Cloudflare serves as a reverse proxy service for that website, and actually, the website is hosted by Amazon Web Services.
- 17. Each Plaintiff has informed me that his name is included within the stolen Ashley Madison database available through the Roe Websites.
- 18. Each Plaintiff has also informed me that Ashley Madison's guarantees of confidentiality and anonymity were crucial prerequisites to his registration with the Ashley Madison website. Each Plaintiff has also informed me that the public disclosure of his use of the Ashley Madison website has caused him great shame, embarrassment, and anxiety, and it threatens to disrupt and seriously interfere with his family relationships.
- 19. Attached hereto as **Exhibit N** is a true and correct screenshot of the webpage located at <downlow.ashleymadison.com>, which my office captured on September 9, 2015.

My office downloaded this article from the International Business Times website on September 10, 2015.
- 24. Attached hereto as **Exhibit S** is a true and correct printout of the checkout the GoDaddy.com, LLC ("GoDaddy") website, page on located <cart.godaddy.com/Checkout/Payment.aspx>, which my office printed out on September 10, 2015. My office encountered this checkout page after going through the process of purchasing a website hosting account through the GoDaddy website. Exhibit S shows that registrants must provide GoDaddy with several pieces of personal information before purchasing GoDaddy's website hosting services.
- 25. Attached hereto as **Exhibit T** are true and correct printouts of the checkout pages from the Amazon Web Services, Inc. ("Amazon") website, located <aws.amazon.com>, which my office printed out on September 10, 2015. My office encountered these checkout pages after going through the process of signing up for an Amazon cloud website hosting account. Exhibit T shows that registrants must provide Amazon with several pieces of personal information before enrolling in/purchasing

Amazon's website hosting services. 1 2 26. I believe that my office has exhausted all possible non-judicial means to 3 identify the Roe Defendants. My office's technical staff reviewed all of the Roe Websites 4 along with all of the user account information associated with the Roe Websites, including 5 the archived WHOIS information and hosting data. My office also reviewed the source code and meta-data associated with the Roe Websites in a further effort to identify the Roe 7 Defendants. My office also searched for and reviewed other websites ostensibly created by 8 the Roe Defendants in an effort to bootstrap unrelated information into the identification of a Roe Defendant. My office spent several hours analyzing all of this data in an effort to 10 identify the Roe Defendants. 11 27. During the week of September 7, 2015, my colleague Ginny Sanderson and I 12 conferred with counsel for Amazon and GoDaddy multiple times about this lawsuit, 13 Plaintiffs' request for early discovery, and Plaintiffs' request for a temporary restraining 14 order and preliminary injunction. Among other things, Ginny and I asked whether Amazon 15 and GoDaddy would be willing to identify the registrants/operators of the Roe Websites 16 without the need for judicial process. 17 I declare under penalty of perjury under the laws of the United States of America 18 that the foregoing is true and correct and that this Declaration was executed on September 19 11, 2015, in San Francisco, California. 20 s/ Karl S. 

The protection of your privacy is very important and we have adopted the following practices to safeguard the confidentiality of your personal information.

What Information is collected?

We collect two types of information: personally identifiable information ("PII") and non-personally identifiable information ("Non-PII"), which is also referred to as aggregate and anonymous data.

Non-PII

We may share some of this Non-PII for our own analysis and research purposes with our professional advisors or consultants and third party partners.

PII

The PII we collect from you is used in the course of providing the Service to you and to improve the content and functionality of the Website or customize the layout of the pages of the Website for each individual user. We may use your contact information to send you valuable updates and timely notices of promotions and mailbox status reports. We may also use your PII to send electronic mail to you, for the purpose of informing you of changes or additions to the Service, or of any Ashley Madison products and services.

The PII we collect is not released to any non-affiliated third party without your prior consent, except as provided below:

Financial Information

Under some circumstances we may require certain additional information, including but not limited to your credit card billing information. We use this financial information, including your name, address, and other information to bill you for use of our Service and products. By making a purchase, or engaging in any other kind of activity or transaction that uses financial information on the Website, you consent to our providing of your financial information to our service providers and to such third parties as we determine necessary to support and process your activities and transactions, as well as to your credit card issuer for its purposes. These third parties may include the credit card companies, data processing companies and banking institutions used to process and support your transaction or activity.

Trusted Third-Parties

Unless you opt out, we may share PII sometimes in connection with Non-PII with service providers that may be associated with us to perform functions on our behalf. In addition, unless you opt out, from time to time we may share and/or sell PII about our users (such as your mailing or email addresses) with selected third parties, so they can offer goods and services that we believe may be of interest or benefit to our users. If you prefer not to receive messages from these third parties you may notify us by opting out at any time by going to the "Manage Profile" or "Message Center" sections of your Profile as described more fully below.

Legal Request

Sale or Merger

We would require that these third parties sign non-disclosure agreements and would endeavor to disclose as little PII as possible.

How long do you keep the information I've provided you?

We keep the information you have given us for at least as long as your Profile stays active or hidden.

The Ashley Madison Data Dump, **Explained**

The release of stolen data from Ashley Madison, a dating website marketed at would-be adulterers, promises to roil the marital lives of its members.

It has also underscored the troubling limitations of Internet privacy.

On Tuesday, hackers appeared to make good on a threat to release what they said was 9.7 gigabytes of account and credit card information from 37 million users of the site.

What information was released?

The data includes members' names, user names, addresses, phone numbers and birth dates as well as details of credit card transactions. Member passwords are encrypted, but specific users could be easily targeted for decryption, according to Quartz.

Profiles filled out by users could also contain embarrassing information about their sexual preferences.

The breach also included users of Established Men, a separate site aimed at women looking to date rich men. Both sites are owned by Avid Life Media.

Is the information verified?

Cybersecurity experts are indicating that the data appears to be genuine, but that doesn't mean all of the information is reliable.

Brian Krebs, a security researcher, said in a blog post that he spoke with three people who found their information and the last four digits of their credit card numbers in the database, suggesting they were indeed stolen from the company.

"I'm sure there are millions of AshleyMadison users who wish it weren't so, but there is every indication this dump is the real deal," Mr. Krebs wrote.

Even if the information was taken from Ashley Madison, it's likely some of it was falsified. The site doesn't verify the information it gathers. A reporter at The Intercept — an unmarried woman in New York City — said a man in South Africa had used her email address to create an account.

Who released the information, and why?

A group of hackers calling themselves Impact Team posted a small portion of the data in July, and they threatened to release the rest unless the site was shut down.

The hackers said they were upset about Ashley Madison's policy for deleting user data when requested. The company has long offered members the ability to scrub their profiles and information from the site for \$19, a feature that BuzzFeed News said generated nearly \$2 million in 2014. But, as the breach showed, the data remained.

"We have explained the fraud, deceit, and stupidity of A.L.M. and their members," Impact Team wrote, referring to Avid Life Media. "Now everyone gets to see their data."

How could I check who had an account?

A reminder: The information found in the data has not been verified.

But two different search tools have surfaced that claim to show whether an email address was used.

More than 15,000 email addresses in the breach were hosted on United States government and military servers, The Hill reported.

How has Avid Life Media responded?

The company is cooperating with law enforcement agencies in Canada and the United States to find the hackers. With a business that relies on the trust of its members now in turmoil, Ashley Madison has sharply denounced the hackers' talk of principles.

"This event is not an act of hacktivism, it is an act of criminality," it said in a statement. "It is an illegal action against the individual members of AshleyMadison.com, as well as any freethinking people who choose to engage in fully lawful online activities. The criminal, or criminals, involved in this act have appointed themselves as the moral judge, juror, and executioner, seeing fit to impose a personal notion of virtue on all of society."

After the initial breach, the company said it had adjusted its policy for deleting user data and was taking steps to delete the stolen data.

Ashley Madison hack: How to search adultery website data leak to see if your details are on there

The leaking of data for more than 32 million users from the online cheating websites Ashley Madison and Established Men will have left many today with a few heart palpitations and sweaty palms, with the rest already on the receiving end of some stern words.

While social media is alive with discussion about the rights and wrongs of the data dump, databases have already been put up on conventional websites not to name and shame customers, but so that concerned users can search to see if they are on the list.

Three websites: haveibeenpwned.com, ashleymadisonleakeddata.com and ashleymadisonleaked.com have all been set up for the purpose, although the latter has gone down because it has not been able to handle the overwhelmingly high number of users. In the case of all three the sites will scour the databases to see if the emails are a match.

Anyone who fears their email could have been maliciously put on the site may also do well to avail themselves of the service. Individuals who have downloaded the lists from the dark web are racing against time to upload them onto comprehensive searchable databases.

Already a number of email addresses from employees at companies such as Amazon, Boeing and Sony; governments agencies in the UK, Canada and France; defence contractors like Raytheon and BAE Systems; and banks including JP Morgan, Bank of America and Citigroup have made it on to the conventional web.

The details of customers, their names, ages, weight, height and embarrassingly their sexual preferences and pictures of users in compromising positions are believed to have been

leaked. Perhaps most worryingly information like credit card details, PayPal account information and home addresses have also been made available.

Cyber security company Blue Coat, which has been doing its own research into the data leak, has said the aftermath will last a month and in the coming weeks three prongs of attack by those wishing to gain from the information can be expected:

- 1. Reselling personal data to other cyber attackers: Now that more than 9 gigabytes of data has been released, they may begin to look at the financial value of a target to see if they will profit from the time spent building malware for the attack. This data is most likely to be among some of the most valuable compromised so far. If it is worth \$100 to 'go away' and there are 37m users, this could be one of the largest cyber heists in history.
- **2. Financial or non-financial blackmail** of Ashley Madison and its customers: Not all of the personal data of Ashley Madison users has been released, therefore cyber attackers may go directly to the management, or to the individual users of Ashley Madison and ask for a payment for the release/deletion of personal data. Blackmail can also happen through non-financial means by coercing victims into working with the attackers as an insider.
- **3. Social engineering** to take down bigger business targets: Attackers can identify high value targets who are members of Ashley Madison and collect widely available social media data to impersonate the victim over a long period. If successful, attackers can gain unrestricted access to corporate networks and sensitive work information.









