CLASS ACTION COMPLAINT

DEMAND FOR JURY TRIAL

1 Plaintiff Cheryl Huang (“Plaintiff”), individually and on behalf of all others similarly
2 situated, by and through her attorneys, alleges the following upon information and belief, except as
3 to those allegations concerning Plaintiff, which are alleged upon personal knowledge. Plaintiff’s
4 information and belief is based upon, among other things, her counsel’s investigation, which
5 includes without limitation: (a) review and analysis of regulatory filings made by Intel Corporation
6 (“Intel” or the “Company”) with the United States (“U.S.”) Securities and Exchange Commission
7 (“SEC”); (b) review and analysis of press releases and media reports issued by and disseminated by
8 Intel; and (c) review of other publicly available information concerning Intel.

9 **NATURE OF THE ACTION AND OVERVIEW**

10 1. This is a class action on behalf of persons and entities that purchased or otherwise
11 acquired Intel securities between April 23, 2020 and July 23, 2020, inclusive (the “Class Period”),
12 seeking to pursue remedies under the Securities Exchange Act of 1934 (the “Exchange Act”).

13 2. Intel is a technology company that provides computing, networking, data storage,
14 and communication solutions worldwide. It operates through Data Center Group, Internet of Things
15 Group, Non-Volatile Memory Solutions Group, Programmable Solutions Group, Client Computing
16 Group, and All Other segments.

17 3. According to Intel, its 7-nanometer CPU technology is the next generation following
18 Intel’s 10-nanometer technology. Intel claims that 7-nanometer technology offers double the area
19 efficiency of 10-nanometer products, and will offer 20% higher performance per watt. In May 2019,
20 Intel projected to ship its first 7-nanometer products in 2021.

21 4. On July 23, 2020, after the market closed, Intel disclosed production delays for its 7-
22 nanometer products after the Company had “identified a defect mode in our seven-nanometer
23 process that resulted in yield degradation.”

24 5. On this news, the Company’s share price fell \$9.81, or approximately 16%, to close
25 at \$50.59 per share on July 24, 2020, on unusually heavy trading volume.

26 6. Throughout the Class Period, Defendants made materially false and/or misleading
27 statements, as well as failed to disclose material adverse facts about the Company’s business,
28 operations, and prospects. Specifically, Defendants failed to disclose to investors: (1) that Intel had

1 identified a defect mode in its 7-nanometer process that resulted in yield degradation; (2) that, as a
2 result, the Company would experience a six-month delay in its production schedule for 7-nanometer
3 products; (3) that Intel was reasonably likely to rely on third-party foundries for manufacturing its
4 7-nanometer products; (4) that, as a result of the foregoing, Intel was reasonably likely to lose market
5 share to its competitors who are already selling 7-nanometer products; and (5) that, as a result of the
6 foregoing, Defendants' positive statements about the Company's business, operations, and
7 prospects were materially misleading and/or lacked a reasonable basis.

8 7. As a result of Defendants' wrongful acts and omissions, and the precipitous decline
9 in the market value of the Company's securities, Plaintiff and other Class members have suffered
10 significant losses and damages.

11 **JURISDICTION AND VENUE**

12 8. The claims asserted herein arise under Sections 10(b) and 20(a) of the Exchange Act
13 (15 U.S.C. §§ 78j(b) and 78t(a)) and Rule 10b-5 promulgated thereunder by the SEC (17 C.F.R. §
14 240.10b-5).

15 9. This Court has jurisdiction over the subject matter of this action pursuant to 28 U.S.C.
16 § 1331 and Section 27 of the Exchange Act (15 U.S.C. § 78aa).

17 10. Venue is proper in this Judicial District pursuant to 28 U.S.C. § 1391(b) and Section
18 27 of the Exchange Act (15 U.S.C. § 78aa(c)). Substantial acts in furtherance of the alleged fraud
19 or the effects of the fraud have occurred in this Judicial District. Many of the acts charged herein,
20 including the dissemination of materially false and/or misleading information, occurred in
21 substantial part in this Judicial District. In addition, the Company's principal executive offices are
22 located in this District.

23 11. In connection with the acts, transactions, and conduct alleged herein, Defendants
24 directly and indirectly used the means and instrumentalities of interstate commerce, including the
25 United States mail, interstate telephone communications, and the facilities of a national securities
26 exchange.

PARTIES

1
2 12. Plaintiff Cheryl Huang, as set forth in the accompanying certification, incorporated
3 by reference herein, purchased Intel securities during the Class Period, and suffered damages as a
4 result of the federal securities law violations and false and/or misleading statements and/or material
5 omissions alleged herein.

6 13. Defendant Intel is incorporated under the laws of Delaware with its principal
7 executive offices located in Santa Clara, California. Intel’s common stock trades on the NASDAQ
8 exchange under the symbol “INTC.”

9 14. Defendant Robert H. Swan (“Swan”) was the Chief Executive Officer (“CEO”) of
10 the Company at all relevant times.

11 15. Defendant George S. Davis (“Davis”) was the Chief Financial Officer (“CFO”) of
12 the Company at all relevant times.

13 16. Defendants Swan and Davis (collectively the “Individual Defendants”), because of
14 their positions with the Company, possessed the power and authority to control the contents of the
15 Company’s reports to the SEC, press releases and presentations to securities analysts, money and
16 portfolio managers and institutional investors, *i.e.*, the market. The Individual Defendants were
17 provided with copies of the Company’s reports and press releases alleged herein to be misleading
18 prior to, or shortly after, their issuance and had the ability and opportunity to prevent their issuance
19 or cause them to be corrected. Because of their positions and access to material non-public
20 information available to them, the Individual Defendants knew that the adverse facts specified
21 herein had not been disclosed to, and were being concealed from, the public, and that the positive
22 representations which were being made were then materially false and/or misleading. The
23 Individual Defendants are liable for the false statements pleaded herein.

24 **SUBSTANTIVE ALLEGATIONS**

25 **Background**

26 17. Intel is a technology company that provides computing, networking, data storage,
27 and communication solutions worldwide. It operates through Data Center Group, Internet of Things
28

1 Group, Non-Volatile Memory Solutions Group, Programmable Solutions Group, Client Computing
2 Group, and All Other segments.

3 18. According to Intel, its 7-nanometer CPU technology is the next generation following
4 Intel's 10-nanometer technology. Intel claims that 7-nanometer technology offers double the area
5 efficiency of 10-nanometer products, and will offer 20% higher performance per watt. In May 2019,
6 Intel projected to ship its first 7-nanometer products in 2021.

7 **Materially False and Misleading**

8 **Statements Issued During the Class Period**

9 19. The Class Period begins on April 23, 2020. On that day, the Company announced its
10 first quarter 2020 financial results in a press release that stated, in relevant part:

- 11 • First-quarter revenue was \$19.8 billion, up 23% year-over-year (YoY). Data-
12 centric revenue* grew 34 percent and PC-centric revenue grew 14 percent
YoY.
- 13 • First-quarter GAAP earnings-per-share (EPS) was \$1.31, up 51 percent YoY;
non-GAAP EPS of \$1.45 was up 63 percent.
- 14 • Generated \$6.2 billion cash from operations and \$2.9 billion of free cash flow
15 while strengthening liquidity with \$10.3 billion in new debt and suspension
of share buybacks.
- 16 • Expecting second-quarter revenue of \$18.5 billion; GAAP EPS of \$1.04 and
17 non-GAAP EPS of \$1.10; not providing full-year guidance given significant
economic uncertainty.

18 20. On April 24, 2020, Intel filed its quarterly report on Form 10-Q with the SEC for the
19 period ended March 28, 2020, affirming the previously reported financial results. The report
20 incorporated by reference the risk factors stated in the 2019 annual report filed with the SEC on
21 January 24, 2020. Specifically, Intel stated, in relevant part:

22 **We face significant competition.** . . . Our products primarily compete based on
23 performance, energy efficiency, integration, ease-of-use, innovative design, features,
24 price, quality, reliability, security, software ecosystem and developer support, *time-*
25 *to-market, reliable product roadmap execution*, brand recognition, customer
26 support and customization, and availability. The importance of these factors varies
27 by product—for example, performance is a key competitive factor for data center
platform products, and failure to introduce new products with performance
28 advantages can harm our competitive position and market segment share in our DCG
business. For our memory products, price, density, and non-volatility are among the
most important competitive factors. *We will not realize our strategic goal to become
the leading end-to-end provider for the new data world if our products do not meet*

1 *our customers' requirements across these factors in an increasingly competitive*
2 *landscape.*

3 * * *

4 Most of our competitors rely on third-party foundries, such as Taiwan Semiconductor
5 Manufacturing Company, Ltd. or Samsung Electronics Co., Ltd., and subcontractors
6 for manufacture and assembly and test of their semiconductor components and
7 products. As an IDM, we have higher capital expenditures and R&D spending than
8 many of our "fabless" competitors. We also face new sources of competition as a
9 result of changes in industry participants through, for example, acquisitions or
10 business collaborations, as well as new entrants, including in China, which could
11 have a significant impact on our competitive position.

12 * * *

13 To compete successfully, we must maintain a successful R&D effort, develop new
14 products and production processes, and improve our existing products and processes,
15 all ahead of competitors. We are focusing our R&D efforts across six engineering
16 pillars: process technology, architecture, memory, interconnect, security, and
17 software. These include ambitious initiatives, such as our unified oneAPI portfolio
18 of developer tools, and we cannot guarantee that all of these efforts will deliver the
19 benefits we anticipate. *For example, to the extent we do not timely introduce new*
20 *manufacturing process technologies that improve transistor density with sufficient*
21 *manufacturing yields and operational efficiency, relative to competing foundry*
22 *processes, we can face cost and product performance disadvantages.* Similarly, to
23 the extent our R&D efforts do not timely produce semiconductor designs for our
24 platform products with improvements in areas like performance, performance per
25 watt, die utilization, and core counts, and with new features such as optimizations
26 for AI and other workloads, our competitive position can be harmed.

27 * * *

28 If we are not able to compete effectively, our financial results will be adversely
affected, including reduced revenue and gross margin, and we may be required to
accelerate the write-down of the value of certain assets.

21. The same report also stated, with respect to development of new products:

Our efforts to innovate involve significant expense and carry inherent risks, including
difficulties in designing and developing next-generation process technologies, and
investments in manufacturing assets and facilities that are made years in advance of
the process node introduction. We cannot guarantee that we will realize the expected
benefits of next-generation process technologies, including the expected cost and
density advantages, or that we will achieve an adequate return on our capital
investments, particularly as development of new nodes has grown increasingly
expensive.

1 **Disclosures at the End of the Class Period**

2 23. On July 23, 2020, after the market closed, Intel reported its second quarter 2020
3 financial results in a press release. Therein, the Company disclosed production delays for its 7-
4 nanometer products. Specifically, the press release, stated:

5 The company's 7nm-based CPU product timing is shifting approximately six months
6 relative to prior expectations. The primary driver is the yield of Intel's 7nm process,
7 which based on recent data, is now trending approximately twelve months behind
8 the company's internal target.

9 24. During a conference call held the same day, Intel's CEO, defendant Swan, stated that
10 the Company was considering outsourcing production to a third-party foundry. He stated:

11 We are seeing an approximate six-month shift in our seven-nanometer-based CPU
12 product timing relative to prior expectations. The primary driver is the yield of our
13 seven-nanometer process, which, based on recent data, is now trending
14 approximately 12 months behind our internal target. We have identified a defect
15 mode in our seven-nanometer process that resulted in yield degradation. We've root
16 caused the issue and believe there are no fundamental roadblocks.

17 ***But we have also invested in contingency plans to hedge against further schedule***
18 ***uncertainty.*** We're mitigating the impact of the process delay on our product
19 schedules by leveraging improvements in design methodology such as die
20 disaggregation and advanced packaging. . . . We will continue to invest in our future
21 process technology road map, but we will be pragmatic and objective in deploying
22 the process technology that delivers the most predictability and performance for our
23 customers, ***whether that be on our process, external foundry process, or a***
24 ***combination of both.***

25 25. On this news, the Company's share price fell \$9.81, or approximately 16%, to close
26 at \$50.59 per share on July 24, 2020, on unusually heavy trading volume.

27 **CLASS ACTION ALLEGATIONS**

28 26. Plaintiff brings this action as a class action pursuant to Federal Rule of Civil
Procedure 23(a) and (b)(3) on behalf of a class, consisting of all persons and entities that purchased
or otherwise acquired Intel securities between April 23, 2020 and July 23, 2020, inclusive, and who
were damaged thereby (the "Class"). Excluded from the Class are Defendants, the officers and
directors of the Company, at all relevant times, members of their immediate families and their legal
representatives, heirs, successors, or assigns, and any entity in which Defendants have or had a
controlling interest.

1 27. The members of the Class are so numerous that joinder of all members is
2 impracticable. Throughout the Class Period, Intel's common shares actively traded on the
3 NASDAQ. While the exact number of Class members is unknown to Plaintiff at this time and can
4 only be ascertained through appropriate discovery, Plaintiff believes that there are at least hundreds
5 or thousands of members in the proposed Class. Millions of Intel common stock were traded
6 publicly during the Class Period on the NASDAQ. Record owners and other members of the Class
7 may be identified from records maintained by Intel or its transfer agent and may be notified of the
8 pendency of this action by mail, using the form of notice similar to that customarily used in securities
9 class actions.

10 28. Plaintiff's claims are typical of the claims of the members of the Class as all members
11 of the Class are similarly affected by Defendants' wrongful conduct in violation of federal law that
12 is complained of herein.

13 29. Plaintiff will fairly and adequately protect the interests of the members of the Class
14 and has retained counsel competent and experienced in class and securities litigation.

15 30. Common questions of law and fact exist as to all members of the Class and
16 predominate over any questions solely affecting individual members of the Class. Among the
17 questions of law and fact common to the Class are:

18 (a) whether the federal securities laws were violated by Defendants' acts as
19 alleged herein;

20 (b) whether statements made by Defendants to the investing public during the
21 Class Period omitted and/or misrepresented material facts about the business, operations, and
22 prospects of Intel; and

23 (c) to what extent the members of the Class have sustained damages and the
24 proper measure of damages.

25 31. A class action is superior to all other available methods for the fair and efficient
26 adjudication of this controversy since joinder of all members is impracticable. Furthermore, as the
27 damages suffered by individual Class members may be relatively small, the expense and burden of
28

1 individual litigation makes it impossible for members of the Class to individually redress the wrongs
2 done to them. There will be no difficulty in the management of this action as a class action.

3 **UNDISCLOSED ADVERSE FACTS**

4 32. The market for Intel's securities was open, well-developed and efficient at all
5 relevant times. As a result of these materially false and/or misleading statements, and/or failures to
6 disclose, Intel's securities traded at artificially inflated prices during the Class Period. Plaintiff and
7 other members of the Class purchased or otherwise acquired Intel's securities relying upon the
8 integrity of the market price of the Company's securities and market information relating to Intel,
9 and have been damaged thereby.

10 33. During the Class Period, Defendants materially misled the investing public, thereby
11 inflating the price of Intel's securities, by publicly issuing false and/or misleading statements and/or
12 omitting to disclose material facts necessary to make Defendants' statements, as set forth herein,
13 not false and/or misleading. The statements and omissions were materially false and/or misleading
14 because they failed to disclose material adverse information and/or misrepresented the truth about
15 Intel's business, operations, and prospects as alleged herein.

16 34. At all relevant times, the material misrepresentations and omissions particularized in
17 this Complaint directly or proximately caused or were a substantial contributing cause of the
18 damages sustained by Plaintiff and other members of the Class. As described herein, during the
19 Class Period, Defendants made or caused to be made a series of materially false and/or misleading
20 statements about Intel's financial well-being and prospects. These material misstatements and/or
21 omissions had the cause and effect of creating in the market an unrealistically positive assessment
22 of the Company and its financial well-being and prospects, thus causing the Company's securities
23 to be overvalued and artificially inflated at all relevant times. Defendants' materially false and/or
24 misleading statements during the Class Period resulted in Plaintiff and other members of the Class
25 purchasing the Company's securities at artificially inflated prices, thus causing the damages
26 complained of herein when the truth was revealed.

1 **LOSS CAUSATION**

2 35. Defendants' wrongful conduct, as alleged herein, directly and proximately caused
3 the economic loss suffered by Plaintiff and the Class.

4 36. During the Class Period, Plaintiff and the Class purchased Intel's securities at
5 artificially inflated prices and were damaged thereby. The price of the Company's securities
6 significantly declined when the misrepresentations made to the market, and/or the information
7 alleged herein to have been concealed from the market, and/or the effects thereof, were revealed,
8 causing investors' losses.

9 **SCIENTER ALLEGATIONS**

10 37. As alleged herein, Defendants acted with scienter since Defendants knew that the
11 public documents and statements issued or disseminated in the name of the Company were
12 materially false and/or misleading; knew that such statements or documents would be issued or
13 disseminated to the investing public; and knowingly and substantially participated or acquiesced in
14 the issuance or dissemination of such statements or documents as primary violations of the federal
15 securities laws. As set forth elsewhere herein in detail, the Individual Defendants, by virtue of their
16 receipt of information reflecting the true facts regarding Intel, their control over, and/or receipt
17 and/or modification of Intel's allegedly materially misleading misstatements and/or their
18 associations with the Company which made them privy to confidential proprietary information
19 concerning Intel, participated in the fraudulent scheme alleged herein.

20 **APPLICABILITY OF PRESUMPTION OF RELIANCE**

21 **(FRAUD-ON-THE-MARKET DOCTRINE)**

22 38. The market for Intel's securities was open, well-developed and efficient at all
23 relevant times. As a result of the materially false and/or misleading statements and/or failures to
24 disclose, Intel's securities traded at artificially inflated prices during the Class Period. On June 5,
25 2020, the Company's share price closed at a Class Period high of \$64.34 per share. Plaintiff and
26 other members of the Class purchased or otherwise acquired the Company's securities relying upon
27 the integrity of the market price of Intel's securities and market information relating to Intel, and
28 have been damaged thereby.

1 39. During the Class Period, the artificial inflation of Intel’s shares was caused by the
2 material misrepresentations and/or omissions particularized in this Complaint causing the damages
3 sustained by Plaintiff and other members of the Class. As described herein, during the Class Period,
4 Defendants made or caused to be made a series of materially false and/or misleading statements
5 about Intel’s business, prospects, and operations. These material misstatements and/or omissions
6 created an unrealistically positive assessment of Intel and its business, operations, and prospects,
7 thus causing the price of the Company’s securities to be artificially inflated at all relevant times, and
8 when disclosed, negatively affected the value of the Company shares. Defendants’ materially false
9 and/or misleading statements during the Class Period resulted in Plaintiff and other members of the
10 Class purchasing the Company’s securities at such artificially inflated prices, and each of them has
11 been damaged as a result.

12 40. At all relevant times, the market for Intel’s securities was an efficient market for the
13 following reasons, among others:

14 (a) Intel shares met the requirements for listing, and was listed and actively
15 traded on the NASDAQ, a highly efficient and automated market;

16 (b) As a regulated issuer, Intel filed periodic public reports with the SEC and/or
17 the NASDAQ;

18 (c) Intel regularly communicated with public investors via established market
19 communication mechanisms, including through regular dissemination of press releases on the
20 national circuits of major newswire services and through other wide-ranging public disclosures,
21 such as communications with the financial press and other similar reporting services; and/or

22 (d) Intel was followed by securities analysts employed by brokerage firms who
23 wrote reports about the Company, and these reports were distributed to the sales force and certain
24 customers of their respective brokerage firms. Each of these reports was publicly available and
25 entered the public marketplace.

26 41. As a result of the foregoing, the market for Intel’s securities promptly digested
27 current information regarding Intel from all publicly available sources and reflected such
28 information in Intel’s share price. Under these circumstances, all purchasers of Intel’s securities

1 during the Class Period suffered similar injury through their purchase of Intel's securities at
2 artificially inflated prices and a presumption of reliance applies.

3 42. A Class-wide presumption of reliance is also appropriate in this action under the
4 Supreme Court's holding in *Affiliated Ute Citizens of Utah v. United States*, 406 U.S. 128 (1972),
5 because the Class's claims are, in large part, grounded on Defendants' material misstatements and/or
6 omissions. Because this action involves Defendants' failure to disclose material adverse
7 information regarding the Company's business operations and financial prospects—information that
8 Defendants were obligated to disclose—positive proof of reliance is not a prerequisite to recovery.
9 All that is necessary is that the facts withheld be material in the sense that a reasonable investor
10 might have considered them important in making investment decisions. Given the importance of
11 the Class Period material misstatements and omissions set forth above, that requirement is satisfied
12 here.

13 **NO SAFE HARBOR**

14 43. The statutory safe harbor provided for forward-looking statements under certain
15 circumstances does not apply to any of the allegedly false statements pleaded in this Complaint. The
16 statements alleged to be false and misleading herein all relate to then-existing facts and conditions.
17 In addition, to the extent certain of the statements alleged to be false may be characterized as forward
18 looking, they were not identified as "forward-looking statements" when made and there were no
19 meaningful cautionary statements identifying important factors that could cause actual results to
20 differ materially from those in the purportedly forward-looking statements. In the alternative, to the
21 extent that the statutory safe harbor is determined to apply to any forward-looking statements
22 pleaded herein, Defendants are liable for those false forward-looking statements because at the time
23 each of those forward-looking statements was made, the speaker had actual knowledge that the
24 forward-looking statement was materially false or misleading, and/or the forward-looking statement
25 was authorized or approved by an executive officer of Intel who knew that the statement was false
26 when made.

FIRST CLAIM
Violation of Section 10(b) of The Exchange Act and
Rule 10b-5 Promulgated Thereunder
Against All Defendants

4 44. Plaintiff repeats and re-alleges each and every allegation contained above as if fully
5 set forth herein.

6 45. During the Class Period, Defendants carried out a plan, scheme and course of conduct
7 which was intended to and, throughout the Class Period, did: (i) deceive the investing public,
8 including Plaintiff and other Class members, as alleged herein; and (ii) cause Plaintiff and other
9 members of the Class to purchase Intel's securities at artificially inflated prices. In furtherance of
10 this unlawful scheme, plan and course of conduct, Defendants, and each defendant, took the actions
11 set forth herein.

12 46. Defendants (i) employed devices, schemes, and artifices to defraud; (ii) made untrue
13 statements of material fact and/or omitted to state material facts necessary to make the statements
14 not misleading; and (iii) engaged in acts, practices, and a course of business which operated as a
15 fraud and deceit upon the purchasers of the Company's securities in an effort to maintain artificially
16 high market prices for Intel's securities in violation of Section 10(b) of the Exchange Act and Rule
17 10b-5. All Defendants are sued either as primary participants in the wrongful and illegal conduct
18 charged herein or as controlling persons as alleged below.

19 47. Defendants, individually and in concert, directly and indirectly, by the use, means or
20 instrumentalities of interstate commerce and/or of the mails, engaged and participated in a
21 continuous course of conduct to conceal adverse material information about Intel's financial well-
22 being and prospects, as specified herein.

23 48. Defendants employed devices, schemes and artifices to defraud, while in possession
24 of material adverse non-public information and engaged in acts, practices, and a course of conduct
25 as alleged herein in an effort to assure investors of Intel's value and performance and continued
26 substantial growth, which included the making of, or the participation in the making of, untrue
27 statements of material facts and/or omitting to state material facts necessary in order to make the
28 statements made about Intel and its business operations and future prospects in light of the

1 circumstances under which they were made, not misleading, as set forth more particularly herein,
2 and engaged in transactions, practices and a course of business which operated as a fraud and deceit
3 upon the purchasers of the Company's securities during the Class Period.

4 49. Each of the Individual Defendants' primary liability and controlling person liability
5 arises from the following facts: (i) the Individual Defendants were high-level executives and/or
6 directors at the Company during the Class Period and members of the Company's management team
7 or had control thereof; (ii) each of these defendants, by virtue of their responsibilities and activities
8 as a senior officer and/or director of the Company, was privy to and participated in the creation,
9 development and reporting of the Company's internal budgets, plans, projections and/or reports;
10 (iii) each of these defendants enjoyed significant personal contact and familiarity with the other
11 defendants and was advised of, and had access to, other members of the Company's management
12 team, internal reports and other data and information about the Company's finances, operations, and
13 sales at all relevant times; and (iv) each of these defendants was aware of the Company's
14 dissemination of information to the investing public which they knew and/or recklessly disregarded
15 was materially false and misleading.

16 50. Defendants had actual knowledge of the misrepresentations and/or omissions of
17 material facts set forth herein, or acted with reckless disregard for the truth in that they failed to
18 ascertain and to disclose such facts, even though such facts were available to them. Such defendants'
19 material misrepresentations and/or omissions were done knowingly or recklessly and for the purpose
20 and effect of concealing Intel's financial well-being and prospects from the investing public and
21 supporting the artificially inflated price of its securities. As demonstrated by Defendants'
22 overstatements and/or misstatements of the Company's business, operations, financial well-being,
23 and prospects throughout the Class Period, Defendants, if they did not have actual knowledge of the
24 misrepresentations and/or omissions alleged, were reckless in failing to obtain such knowledge by
25 deliberately refraining from taking those steps necessary to discover whether those statements were
26 false or misleading.

27 51. As a result of the dissemination of the materially false and/or misleading information
28 and/or failure to disclose material facts, as set forth above, the market price of Intel's securities was

1 artificially inflated during the Class Period. In ignorance of the fact that market prices of the
2 Company's securities were artificially inflated, and relying directly or indirectly on the false and
3 misleading statements made by Defendants, or upon the integrity of the market in which the
4 securities trades, and/or in the absence of material adverse information that was known to or
5 recklessly disregarded by Defendants, but not disclosed in public statements by Defendants during
6 the Class Period, Plaintiff and the other members of the Class acquired Intel's securities during the
7 Class Period at artificially high prices and were damaged thereby.

8 52. At the time of said misrepresentations and/or omissions, Plaintiff and other members
9 of the Class were ignorant of their falsity, and believed them to be true. Had Plaintiff and the other
10 members of the Class and the marketplace known the truth regarding the problems that Intel was
11 experiencing, which were not disclosed by Defendants, Plaintiff and other members of the Class
12 would not have purchased or otherwise acquired their Intel securities, or, if they had acquired such
13 securities during the Class Period, they would not have done so at the artificially inflated prices
14 which they paid.

15 53. By virtue of the foregoing, Defendants violated Section 10(b) of the Exchange Act
16 and Rule 10b-5 promulgated thereunder.

17 54. As a direct and proximate result of Defendants' wrongful conduct, Plaintiff and the
18 other members of the Class suffered damages in connection with their respective purchases and
19 sales of the Company's securities during the Class Period.

20 **SECOND CLAIM**
21 **Violation of Section 20(a) of The Exchange Act**
22 **Against the Individual Defendants**

23 55. Plaintiff repeats and re-alleges each and every allegation contained above as if fully
24 set forth herein.

25 56. Individual Defendants acted as controlling persons of Intel within the meaning of
26 Section 20(a) of the Exchange Act as alleged herein. By virtue of their high-level positions and their
27 ownership and contractual rights, participation in, and/or awareness of the Company's operations
28 and intimate knowledge of the false financial statements filed by the Company with the SEC and
disseminated to the investing public, Individual Defendants had the power to influence and control

1 and did influence and control, directly or indirectly, the decision-making of the Company, including
2 the content and dissemination of the various statements which Plaintiff contends are false and
3 misleading. Individual Defendants were provided with or had unlimited access to copies of the
4 Company's reports, press releases, public filings, and other statements alleged by Plaintiff to be
5 misleading prior to and/or shortly after these statements were issued and had the ability to prevent
6 the issuance of the statements or cause the statements to be corrected.

7 57. In particular, Individual Defendants had direct and supervisory involvement in the
8 day-to-day operations of the Company and, therefore, had the power to control or influence the
9 particular transactions giving rise to the securities violations as alleged herein, and exercised the
10 same.

11 58. As set forth above, Intel and Individual Defendants each violated Section 10(b) and
12 Rule 10b-5 by their acts and omissions as alleged in this Complaint. By virtue of their position as
13 controlling persons, Individual Defendants are liable pursuant to Section 20(a) of the Exchange Act.
14 As a direct and proximate result of Defendants' wrongful conduct, Plaintiff and other members of
15 the Class suffered damages in connection with their purchases of the Company's securities during
16 the Class Period.

17 **PRAYER FOR RELIEF**

18 WHEREFORE, Plaintiff prays for relief and judgment, as follows:

19 (a) Determining that this action is a proper class action under Rule 23 of the Federal
20 Rules of Civil Procedure;

21 (b) Awarding compensatory damages in favor of Plaintiff and the other Class members
22 against all defendants, jointly and severally, for all damages sustained as a result of Defendants'
23 wrongdoing, in an amount to be proven at trial, including interest thereon;

24 (c) Awarding Plaintiff and the Class their reasonable costs and expenses incurred in this
25 action, including counsel fees and expert fees; and

26 (d) Such other and further relief as the Court may deem just and proper.

27 **JURY TRIAL DEMANDED**

28 Plaintiff hereby demands a trial by jury.
