PROCEDURAL ORDER NO. 2

The Presiding Officer in this Docket makes the following findings and conclusions:

- 1. On June 10, 2024, Sierra Pacific Power Company d/b/a NV Energy ("Sierra") and Callisto Enterprises LLC ("Google" and together with Sierra, "Joint Applicants") filed with the Public Utilities Commission of Nevada ("Commission") a joint application, designated as Docket No. 24-06014 ("Joint Application"), for approval of an Energy Supply Agreement ("ESA"). Joint Applicants filed the Joint Application pursuant to the Nevada Revised Statutes ("NRS") and the Nevada Administrative Code ("NAC"), Chapters 703 and 704, including, but not limited to, NAC 703.535 and the Clean Transition Tariff ("CTT") that is pending approval in Docket No. 24-05023. Pursuant to NRS 703.190 and NAC 703.527 *et seq.*, Joint Applicants request that certain material in the Joint Application receive confidential treatment.
- 2. On June 17, 2024, the Commission issued a Notice of Application for Approval of an Energy Supply Agreement and Notice of Prehearing Conference.
- 3. The Regulatory Operations Staff of the Commission ("Staff") participates as a matter of right pursuant to NRS 703.301.
- 4. On June 20, 2024, the Bureau of Consumer Protection ("BCP") filed a Notice of Intent to Intervene, pursuant to NRS 228.360.
- 5. On July 12, 2024, the Presiding Officer held a prehearing conference attended by the Joint Applicants, Staff and BCP, wherein two potential procedural schedules were discussed, depending on the procedural schedule adopted in Consolidated Docket Nos. 24-05022 and 24-

05023.

6. On July 23, 2024, the Commission issued Procedural Order No. 1, setting a Continued Prehearing Conference for December 3, 2024.

- 7. On August 12, 2024, Joint Applicants filed an Amendment to the Application.
- 8. On December 3, 2024, the Presiding Officer held a prehearing conference attended by the Joint Applicants, Staff and BCP, wherein the procedural schedule was discussed.

A. Procedural Schedule

- 9. The following procedural schedule is hereby established:
 - a. BCP and Staff shall file with the Commission and serve on all parties of record PREPARED DIRECT TESTIMONY on or before WEDNESDAY, APRIL 30, 2025, by 2:00 p.m.
 - b. Joint Applicants shall file with the Commission and serve on all parties of record PREPARED REBUTTAL TESTIMONY on or before WEDNESDAY, MAY 14, 2025, by 2:00 p.m.
 - c. The Presiding Officer will hold a HEARING on THURSDAY, MAY 29, 2025, at 10:00 a.m., at the Commission's offices in Carson City, Nevada, with videoconference to Las Vegas, Nevada.

B. Discovery Disputes

- 10. If a party seeks resolution of a dispute concerning discovery pursuant to NAC 703.680(10), the party may request a telephone conference with the Presiding Officer and the other parties in lieu of filing a motion.
- 11. Pursuant to NAC 703.690(1)(g), the Presiding Officer may issue appropriate interim orders.
