To amend the Artificial Intelligence Training for the Acquisition Workforce Act to expand AI training within the executive branch of the Federal Government, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “AI Training Extension
5 Act of 2025”.

1 **SEC. 2. EXPANSION OF AI TRAINING WITHIN THE EXECU-**
2 **TIVE BRANCH OF THE FEDERAL GOVERN-**
3 **MENT.**

4 (a) IN GENERAL.—Section 2 of the Artificial Intel-
5 ligence Training for the Acquisition Workforce Act (Public
6 Law 117–207; 41 U.S.C. 1703 note) is amended—

7 (1) in subsection (a)—

8 (A) by striking paragraph (4);

9 (B) by redesignating paragraphs (1), (2),
10 (3), and (5), as (3), (4), (5), and (7), respec-
11 tively;

12 (C) by inserting before paragraph (3), as
13 so redesignated, the following:

14 “(1) ACQUISITION POSITION.—The term ‘acqui-
15 sition position’ means any position listed in sub-
16 section (g)(1)(A) of section 1703 of title 41, United
17 States Code.

18 “(2) ADMINISTRATOR.—The term ‘Adminis-
19 trator’ means the Administrator of General Serv-
20 ices.”;

21 (D) in paragraph (5), as so redesignated—

22 (i) by striking subparagraph (A);

23 (ii) by redesignating subparagraph

24 (B) as subparagraph (E); and

25 (iii) inserting before subparagraph

26 (E), as so redesignated, the following:

1 “(A) an employee of an executive agency
2 serving in an acquisition position;

3 “(B) a management official;

4 “(C) a supervisor;

5 “(D) an employee serving in a data or
6 technology position; and”;

7 (E) by inserting before paragraph (7), as
8 so redesignated, the following:

9 “(6) DATA OR TECHNOLOGY POSITION.—The
10 term ‘data or technology position’ means a position
11 that is classified to an occupational series within the
12 Mathematical Sciences Group or to the Information
13 Technology Group identified by the Director of the
14 Office of Personnel Management.”; and

15 (F) by adding at the end the following:

16 “(8) MANAGEMENT OFFICIAL.—The term ‘man-
17 agement official’ has the meaning given the term in
18 section 7103(a) of title 5, United States Code.

19 “(9) SUPERVISOR.—The term ‘supervisor’ has
20 the meaning given the term in section 7103(a) of
21 title 5, United States Code.”; and

22 (2) in subsection (b)—

23 (A) in paragraph (1)—

24 (i) by striking “(1) IN GENERAL.—
25 Not” and inserting the following:

1 “(1) IN GENERAL.—

2 “(A) ESTABLISHMENT OF PROGRAM.—

3 Not”;

4 (ii) by striking “the Director, in co-
5 ordination with the Administrator of Gen-
6 eral Services and any other person deter-
7 mined relevant by the Director” and in-
8 serting “the Administrator, in coordination
9 with the Director of the Office of Manage-
10 ment and Budget and any other person de-
11 termined relevant by the Administrator”;
12 and

13 (iii) by adding at the end the fol-
14 lowing:

15 “(B) INCORPORATION OF EXISTING TRAIN-
16 ING PERMITTED.—For the purposes of subpara-
17 graph (A), the Administrator may incorporate
18 the AI training program described under sub-
19 paragraph (A) into any other training program
20 that the Administrator determines relevant to
21 providing the information required under para-
22 graph (3), including training programs offered
23 under section 4103 of title 5, United States
24 Code.”;

1 (B) in paragraph (2), by striking “knowl-
2 edge” and all that follows through the period at
3 the end and inserting the following: “knowledge
4 regarding—

5 “(A) the capabilities and risks associated
6 with AI; and

7 “(B) requirements and best practices es-
8 tablished by the Administrator with respect to
9 AI and in accordance with the guidance estab-
10 lished by the Director of the Office of Manage-
11 ment and Budget under section 104 of the AI
12 in Government Act of 2020 (Public Law 116–
13 260; 40 U.S.C. 11301 note) and section 7224
14 and 7225 of the Advancing American AI Act
15 (subtitle B of title LXXII of Public Law 117–
16 263; 40 U.S.C. 11301 note) as applicable.”;

17 (C) in paragraph (3)—

18 (i) in subparagraph (A), by striking
19 “the science underlying AI, including” and
20 inserting “what AI is and”;

21 (ii) in subparagraph (B), by striking
22 “artificial intelligence systems” and insert-
23 ing “AI”;

24 (iii) by amending subparagraph (C) to
25 read as follows: “the potential benefits

1 posed by AI, including such potential bene-
2 fits to the Federal Government;”;

3 (iv) in subparagraph (D), by inserting
4 “and the risks posed to the Federal Gov-
5 ernment” after “privacy”;

6 (v) in subparagraph (E), by striking
7 “; and” and inserting a semicolon;

8 (vi) by amending subparagraph (F) to
9 read as follows: “what executive agencies
10 should consider with respect to develop-
11 ment, deployment, and management of AI
12 by executive agencies; and”; and

13 (vii) by adding at the end the fol-
14 lowing:

15 “(G) the role of data in developing and op-
16 erating AI.”;

17 (D) in paragraph (4)—

18 (i) in the matter preceding subpara-
19 graph (A), by striking “Director” and in-
20 serting “Administrator”;

21 (ii) in subparagraph (A), by striking
22 “; and” and inserting a semicolon;

23 (iii) in subparagraph (B), by striking
24 the period at the end and inserting “;
25 and”; and

1 (iv) by adding at the end the fol-
2 lowing:

3 “(C) incorporate, as practicable, any feed-
4 back from participants received under para-
5 graph (6).”;

6 (E) in paragraph (5), by striking “Direc-
7 tor” and inserting “Administrator”; and

8 (F) in paragraph (6)—

9 (i) in the matter preceding subpara-
10 graph (A), by striking “Director shall en-
11 sure the existence of” and insert “Admin-
12 istrator shall establish”; and

13 (ii) in subparagraph (B), by inserting
14 “through any update to such program
15 under paragraph (4)” before the period at
16 the end.

17 (b) AMENDMENT TO SHORT TITLE OF ARTIFICIAL
18 INTELLIGENCE TRAINING FOR THE ACQUISITION WORK-
19 FORCE ACT.—

20 (1) IN GENERAL.—Section 1 of the Artificial
21 Intelligence Training for the Acquisition Workforce
22 Act (Public Law 117–207; 41 U.S.C. 1703 note) is
23 amended by striking “‘for the Acquisition Work-
24 force’ ”.

1 (2) RULE OF CONSTRUCTION.—Any reference
2 in law, regulation, document, paper, or other record
3 to the Artificial Intelligence Training for the Acqui-
4 sition Workforce Act shall be construed as referring
5 to the Artificial Intelligence Training Act.
